**Flavor of Fishers**  
**Family Fun Zone Application**  
**Information, Rules and Regulations**

**Purpose:** We wish to have a fun and enjoyable Family Fun Zone for this year's Flavor of Fishers! To that end, we want booths which are interactive with children in a positive way.

As a condition for participation, each organization must provide an interactive game with a giveaway for each child. Please describe your booth game and giveaway in your booth application.

**Booth Fee: \$30.00**

- The minimal fee will help offset cost of signs, staffing and maintenance

**Booth Space:**

- Booth spaces are 15ft. x 10ft
- Organization must provide its own canopies, tents, chairs and tables as needed. All canopies, tables, chairs, game equipment must fit within the booth space.

**Event Hours/Set-Up/Break-Down:**

**New for 2010! The location of the Family Fun Zone has been moved to the lot of the St. Vincent Health building**

The Family Fun Zone will run from noon to 8:00 pm on Saturday, July 31, 2010. Organizations are required to be open by 11:45 a.m. and remain open until 8:00 pm. An organization leaving prior to the close of the Family Fun Zone forfeits an invitation to next year's event. For unloading purposes, vehicles will be allowed in the Family Fun Zone area from 8:00 a.m. to 10:00 a.m. only. You may not begin assembling your booth until after your vehicle is removed from the Family Fun Zone area. All organizations must have their space cleared and cleaned by 9:30 p.m. There will be volunteers available to assist with tear down and load out.

### Clean-Up:

- Clean-up of the booth area is the **responsibility of the organization** including removal of all their trash.
- Trash receptacles will be provided.
- Booth area must be cleaned immediately upon closing booth.

### Give-aways and Games may not include:

- Any item which propels an object
- Items considered a projectile.
- Items which would encourage malicious destruction of property, throwing of the object, misuse of the objects intended use.
- Any item/toy which is similar to or imitates the actions of a firearm, or firework, including but not limited to, poppers, snakes, smokeballs, and sparklers.
- Clothing with profanity or promoting illegal activity.
- No live animals may be distributed or sold on the premises.
- No food can be given away unless it is commercially packaged.

### Booth Décor/Amplified Music:

- The Fishers Chamber of Commerce asks that all Organizations use their booth space for their activities. No item can be displayed or activity held on the common ground of the Family Fun Zone.
- Signage and booth decorations are encouraged as long as they are in good taste and don't interfere with neighboring organizations. You will receive a sign with your booth space.
- The Fishers Chamber of Commerce reserves the right to remove any décor deemed inappropriate for the event.
- Organizations in the Family Fun Zone are not allowed to use amplified devices (i.e. "boom boxes") or any other devices to play music or noise of any kind.

### Electricity:

- Limited electricity will be available to organizations and must be reserved in advance. No electricity can be requested on the day of the Flavor of Fishers event. **No generators are allowed.**

### Space Assignments:

- Booth space assignments and notification will be made on a first come, first served basis, according to the date the completed application and booth fee of \$30 is received. No postdated checks will be accepted.
- Please include check or money order with your application.
- Applications must include Certificate of Liability Insurance naming the Fishers Chamber of Commerce as an additional insured for the event.
- **Organization applications are due by June 1, 2010.**
- Booth confirmations, space assignments and parking passes will be emailed out two (2) weeks prior to the event.

**Additional Policies:**

- Booth participants are responsible for the security of their property.
- Booth participants must be a member of the Fishers Chamber of Commerce.
- Groups must comply with all ordinances, codes, laws, rules and regulations of the Town of Fishers, Hamilton County and State of Indiana.
- The Fishers Chamber of Commerce retains the right to refuse or limit participating organizations.
- The Fishers Chamber of Commerce is not responsible for injury or loss due to fire, theft, vandalism or weather.
- Booths must be staffed the entire hours of the Family Fun Zone.
